It is hereby notified that following are the resolutions of the meeting of the Teachers' Council held on 04/10/2023 (Wednesday):

- 1. As regards the choice of Inter-disciplinary Courses (IDCs)/Multi-disciplinary Courses (MDCs) offered to the Semester I students of Science and Arts streams, it was decided that students enrolled in the B.A. Four/Three-Year Undergraduate Programme will have to opt for/select one from following: IDC/MDC in Botany/Chemistry/Zoology/Environmental Science. Similarly, students enrolled in the B.Sc. Four-Year Undergraduate Programme will have to opt for/select one from the following: IDC/MDC in Bengali/History/Political Science/Sociology. The Officer-In-Charge asked the Secretary, Teachers' Council, to prepare a detailed notification on the IDCs/MDCs on offer so that students are able to make an informed decision. Such notification will be issued shortly.
- 2. Coordinator, NAAC Committee, informed the council that the duly filled in AQAR (Part A and B) for session 2022-2023, with necessary information and supporting documents as far as possible, has already been submitted to the Officer-In-Charge and Coordinator, IQAC. Coordinator, IQAC, informed the council that the final AQAR 2022-2023 will be uploaded on the college website shortly, after verification of the documents submitted by the Coordinator, NAAC Committee.
- 3. The Officer-In-Charge asked the Departments to verify the student data entered by the Office in the *Banglar Ucchasikkha* Portal on an urgent basis within the first half of 6th October, 2023. Departmental Heads were asked to collect related documents from the Office to ensure timely verification of student data.
- 4. As instructed by the Officer-In-Charge, the issue of compliance with official rules and regulations for participating in Faculty Induction Programmes (FIPs)/Refresher Courses (RCs) such as seeking No Objection Certificate from the Head of the Institution before applying for such Programmes/Courses and transferring of charge in person on the last working day for the sanctioning of On Duty Leave from higher authorities in favour of the applicant/incumbent for the period of participation in such programmes/courses was taken up in the meeting.

The Officer-In-Charge informed the council that Dr. Suchismita Das, Assistant Professor in Sociology, cannot be permitted to participate in the Interdisciplinary Refresher Course (Online) on Entrepreneurship Development, organized by UGC-HRDC, Mizoram University, from 04/10/2023 to 17/10/2023 on the ground of non-compliance with official rules, and asked her to resume duties in college on and from 05/10/2023. The Officer-In-Charge however stated unequivocally that she may apply for any other Refresher Course during 2023-2024 as may be required and helpful for career advancement maintaining service rules and regulations. The council seconded the decision of the Officer-In-Charge.
